# OVERVIEW

The San Francisco Health Service System (SFHSS) administers health benefits. Our membership is comprised of employees and retirees of the City and County of San Francisco (CCSF), the San Francisco Unified School District (SFUSD), City College of San Francisco (SFCCD) and the Superior Court of San Francisco (CRT), as well as eligible dependents. This report is based on SFHSS membership demographics as of January 1, 2021.

## Medical Enrollment

The COVID-19 pandemic dominated the healthcare landscape in 2020 and impacted enrollment values. As a result, the IRS allowed for mid-year plan year changes, SFHSS suspended delinquency processing to avoid disruption of care, and hiring/re-hiring of staff was delayed.

## Dental Enrollment

SFHSS administers dental plans for employees and dependents of the City and County of San Francisco and Superior Court of San Francisco, as well as retirees from all employers. Dental benefits for employees are employer-subsidized. Retiree dental plan premiums are paid 100% by the retiree. In 2021, the overall count of enrolled lives decreased by 199 lives.

## Flexible Spending Accounts

Flexible Spending Accounts are IRS-approved, tax-favored accounts that allow employees to reduce out-of-pocket costs for qualified medical, child care and dependent care expenses. The decrease in enrollment in 2021 may be attributable to the pandemic, which impacted access to healthcare providers and demand for dependent care services.

Voluntary benefits offered by SFHSS to City and County of San Francisco and Superior Court of San Francisco employees provide quality coverage at discounted group rates. Voluntary benefits premiums are 100% paid for by the employee and deducted from employee’s pay checks. Enrollment increased in all of the voluntary benefits offered except for Pets Best which dipped slightly.

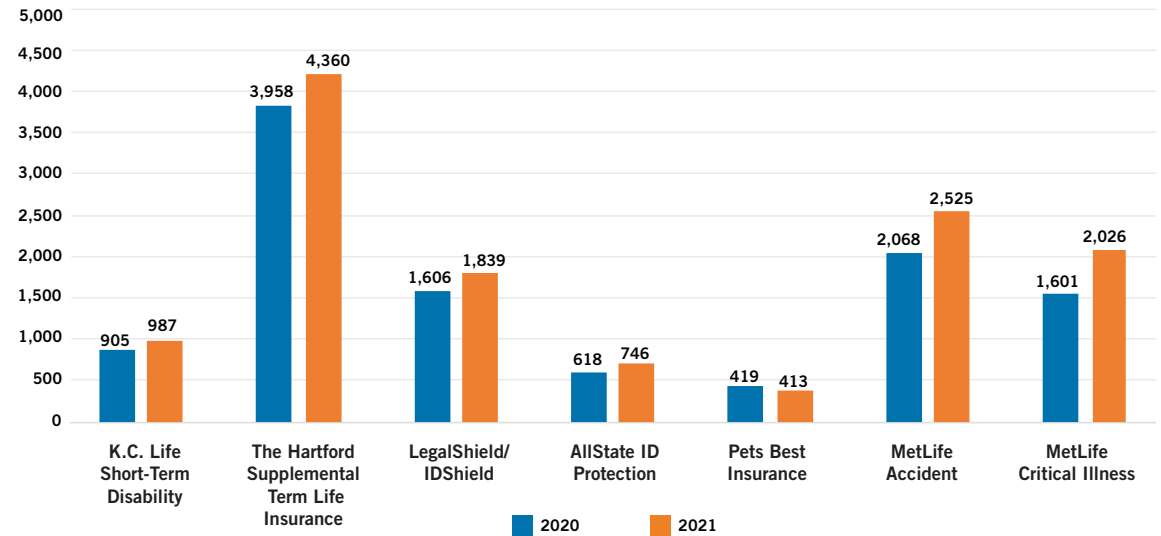
The most popular plans are the Hartford Supplemental Life, MetLife Accident and MetLife Critical Illness.

# ENROLLED LIVES

---

## All Employee and Retiree Members and Dependents

- Enrollment in medical coverage decreased slightly from the previous year. SFHSS covers 124,069 lives, a decrease of 162 lives.
- 38% of the lives (46,983) covered under SFHSS medical plans reside in San Francisco, which is the county with the largest percentage of SFHSS lives.
- Percentage distribution of member lives by geography saw slight changes. Contra Costa, Marin and San Mateo saw decreases in lives by 280, 10 and 5 respectively. San Mateo had the largest gain with 315 lives from last year.
- The proportion of employee to retiree lives enrolled in medical coverage shifted with retiree lives at 33% and employees at 67%.
- SFHSS has an additional 2,812 employee members and 3,159 retiree members who waived medical coverage.

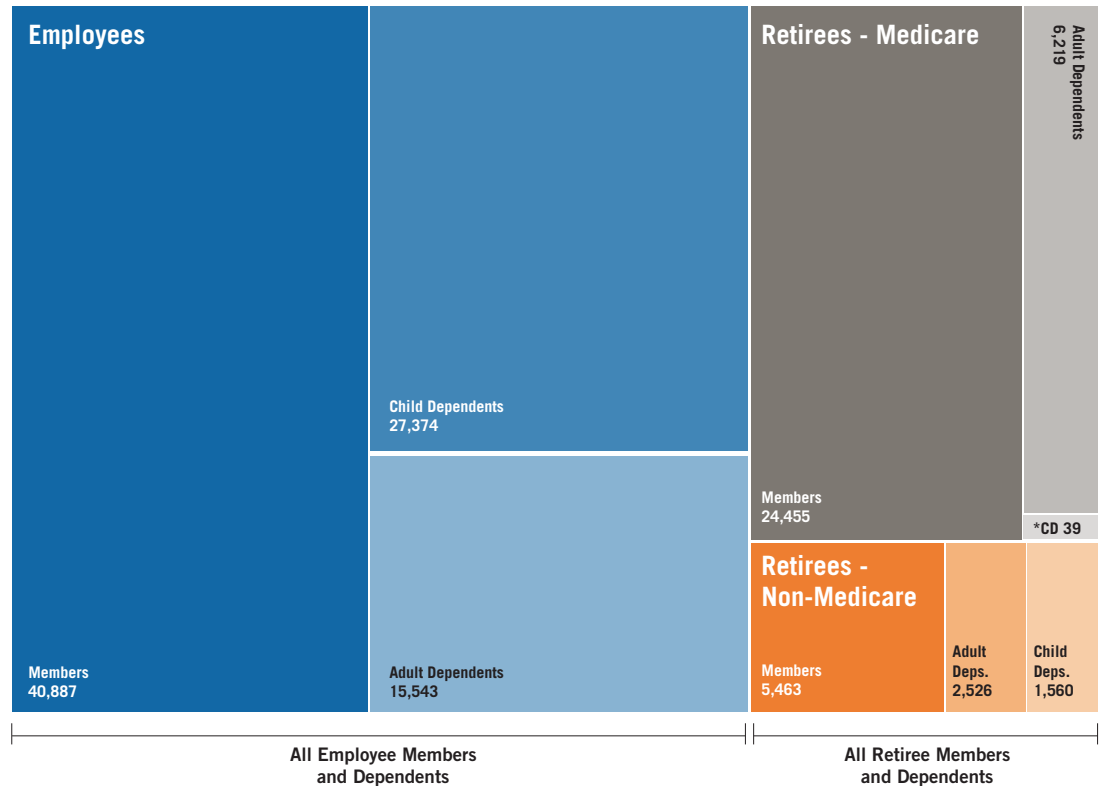
## ALL LIVES COVERED BY SFHSS MEDICAL PLANS: 124,069

### Employees:

- Continuing the trend observed in the last couple of years, the dependent proportion of employee lives continues to increase slightly. In 2021 the driver of the changing ratios is the decrease of employees.
- 47% (19,312) of employees have no dependents enrolled in medical coverage.
- 1,730 employees eligible to enroll in dental have waived coverage. Of those, 280 enrolled in medical but waived dental. The remainder waived both their medical and dental coverage.
- The percent of employees enrolled at the family coverage tier (+2 or more) increased by 1 percent to 28%.

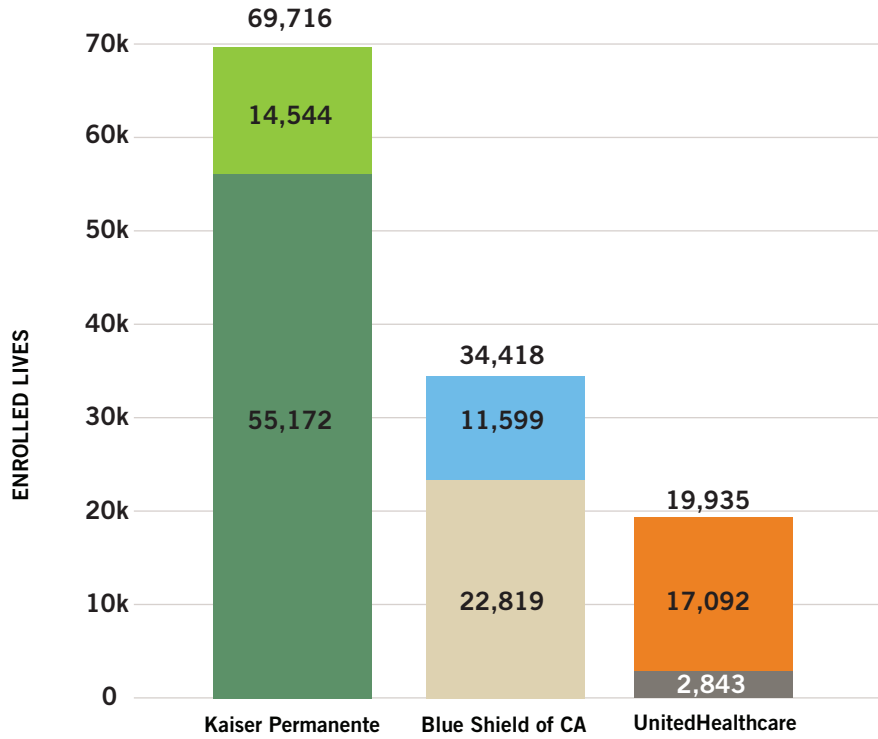
### Retirees:

- 29% of Medicare retirees have dependents enrolled.
- 585 retirees have family coverage (+2 or more), down 42 from previous year.
- Although the proportion of retiree lives to employee lives increased by 1%, the overall count of retiree lives (members and dependents) decreased by 1%.



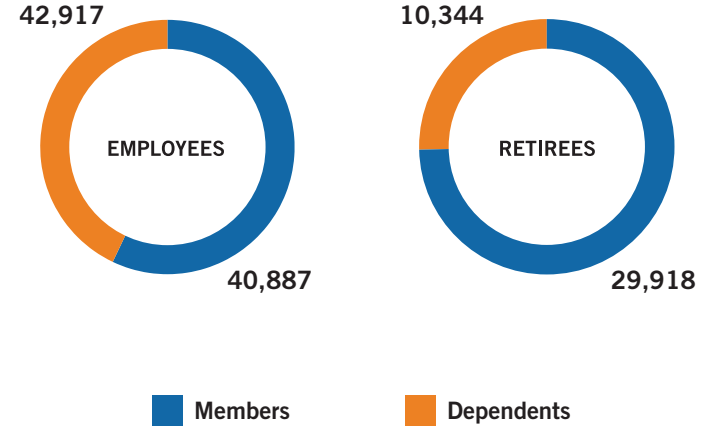

Medical Enrollment: All Covered Lives

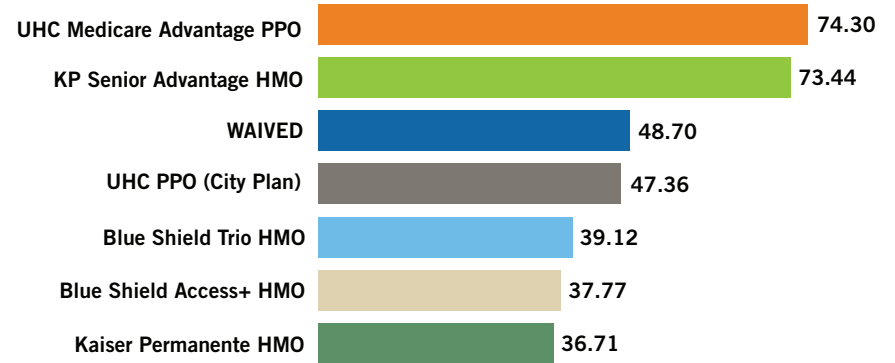

Average Age by Plan: All Covered Lives

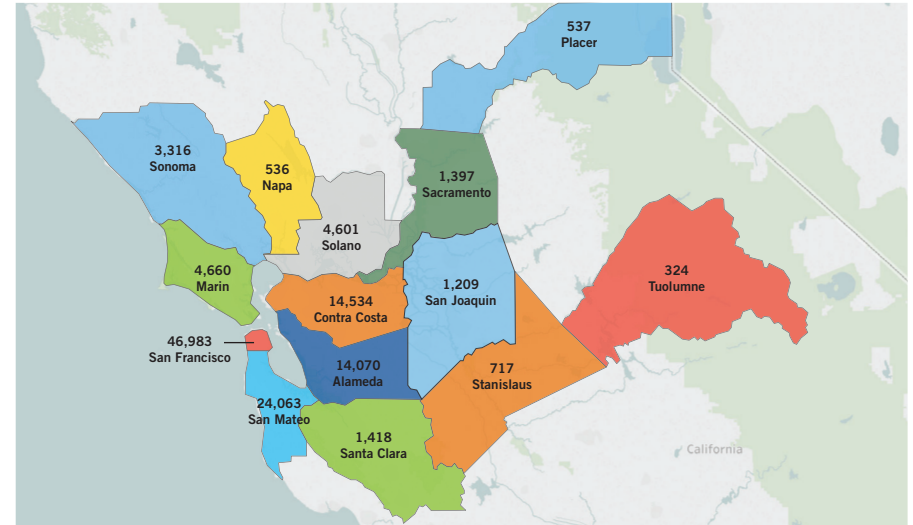

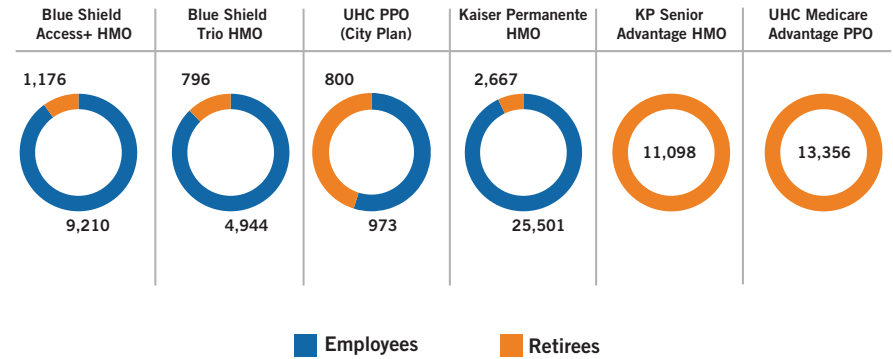
## Employee and Retiree Members For All City Employers

- The number of members covered by medical plans decreased by 215. As of January 2021, a total of 79,805 members were enrolled. SFHSS active employee members decreased by 742 to 40,887 and retirees increased enrollment by 527 to 29,918.
- The number of active and retiree members enrolled in Kaiser Permanente HMO decreased by 284 members and comprises 39% of all member enrollment in 2021.
- Of the 29,910 medically-enrolled retiree members, 24,455 are Medicare retirees and 5,463 are Non-Medicare retirees.
- UnitedHealthcare City Plan PPO enrollment increased by 10 members to 1,867.
- Enrollment in UnitedHealthcare Medicare Advantage PPO increased by 403 members to 13,356.
- 91% of members covered under SFHSS medical plans reside in eight Bay area counties: San Francisco, San Mateo, Alameda, Contra Costa, Marin, Solano, Sonoma and Santa Clara. 41% live in San Francisco.
- The number of employee members with domestic partners decreased by 17; the number of retirees with domestic partners decreased by 2. 1,393 members have a domestic partner enrolled in medical benefits with 76.23% (1,062) of those being opposite-sex unions.
- 57% of employee and retiree members are enrolled in member-only coverage, 26% are enrolled in member plus one dependent and 17% enrolling in member plus two or more dependents.

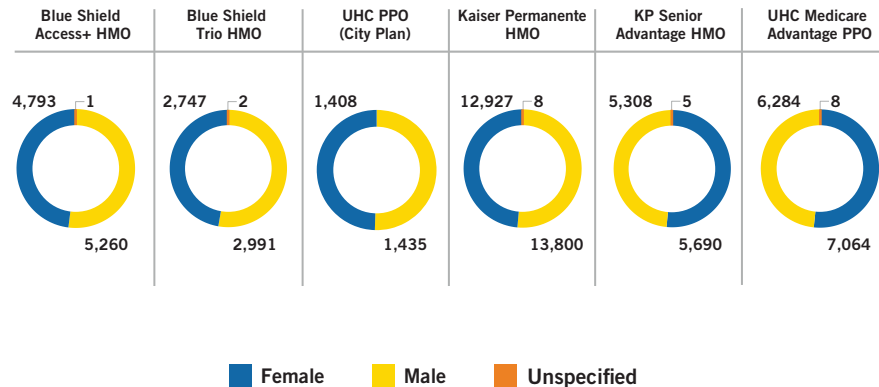
Medical Enrollment: Employee vs. Retiree Average Age



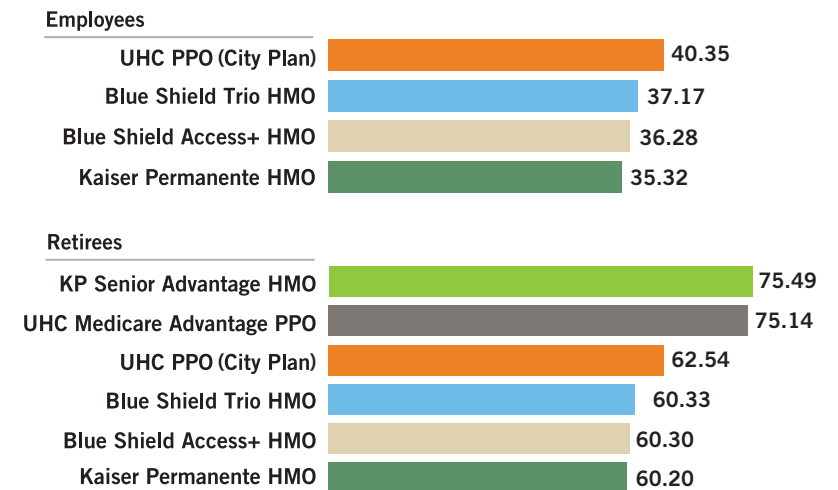
Medical Enrollment: Employee vs. Retiree Members



Medical Enrollment by Gender: Employee and Retiree Members



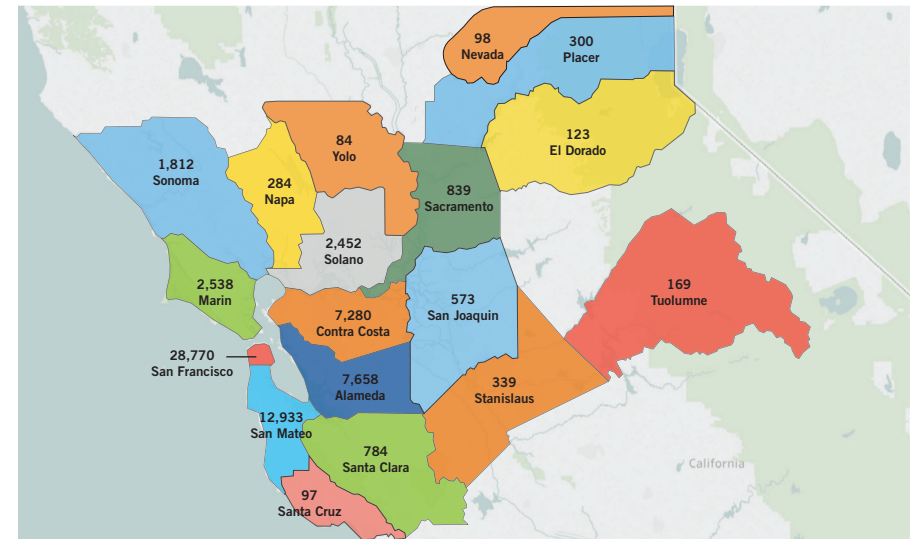
Average Age by Medical Plan: Employee and Retiree Members

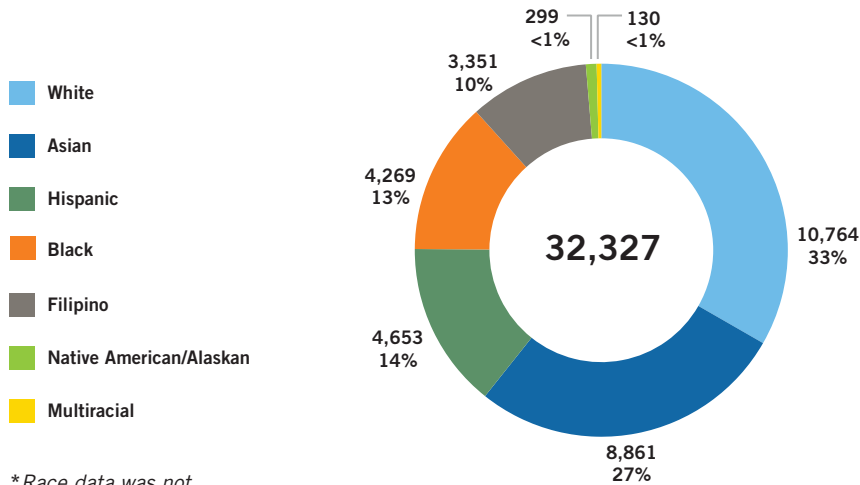

## Employees and Dependents (All Employers)

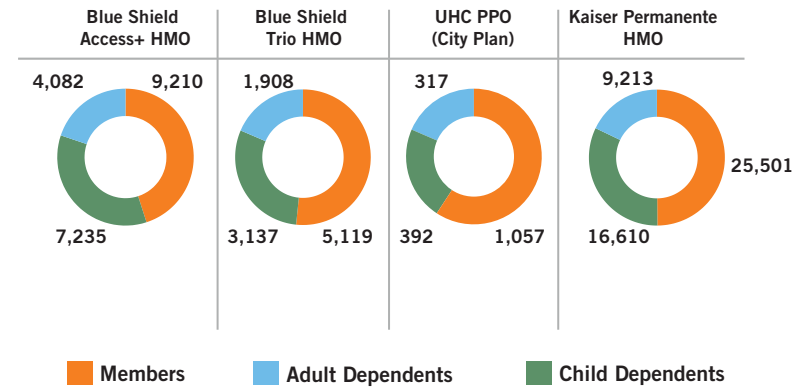
- The number of employee lives covered by SFHSS medical plans saw a slight decrease to 83,804 (from 84,820). In 2021, employee and dependent lives covered by medical plans decreased by 1,016.
- The proportion of employees vs. dependents enrolled in medical coverage has remained static for the last six years with 51% employee members and 49% employee dependents.
- Kaiser Permanente's proportional share of all employee lives is 61%.
- Employees and dependents enrolled in Blue Shield of California HMO account for 24% of employee lives. Blue Shield Trio HMO and Blue Shield Access+ HMO both had decreases from the previous year with enrollment at 10,164 and 20,527 respectively.
- Enrollment in UnitedHealthcare PPO (City Plan) decreased by 17, with a total of 1,766 employees and their dependents enrolled.
- 15% of employee members have enrolled child dependents only. SFHSS does not have the data to determine if these are single parent families, or families where there is another adult with access to other coverage.
- The average age of employee members and dependents is 35.89.
- 96% of employee lives covered under SFHSS medical plans reside in eight Bay Area counties: San Francisco, San Mateo, Alameda, Contra Costa, Solano, Marin, Sonoma and Santa Clara.
- Enrollment by coverage tier shifted 1% from member plus one dependent to members only which now comprises 47%. Members plus one dependent comprise 25% of enrollment and members at the family tier of members plus two or more dependents accounts for 28%.
- 40% of employee members, with or without dependents, live in San Francisco.

Medical Enrollment by Race/Ethnicity: Employees\*

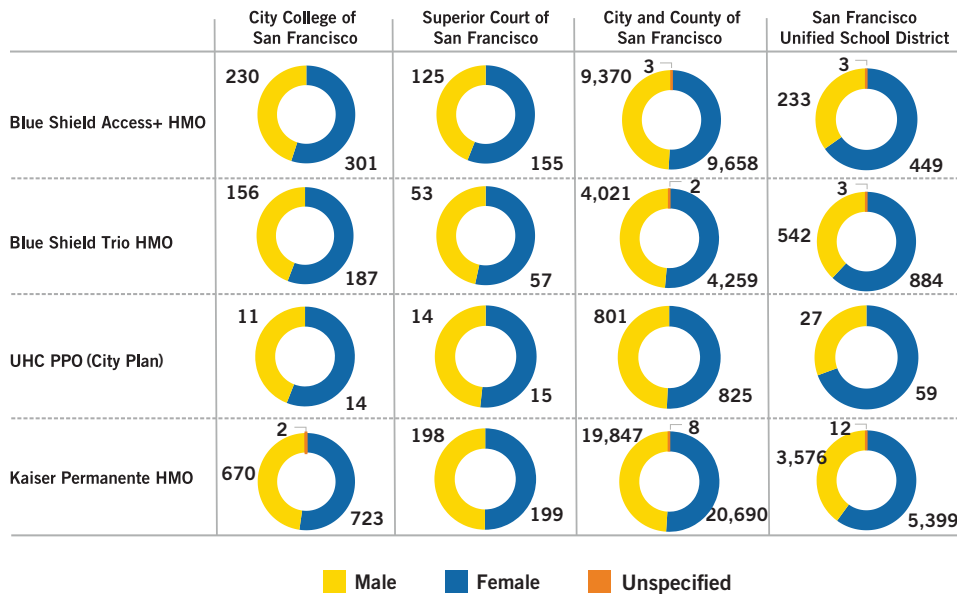

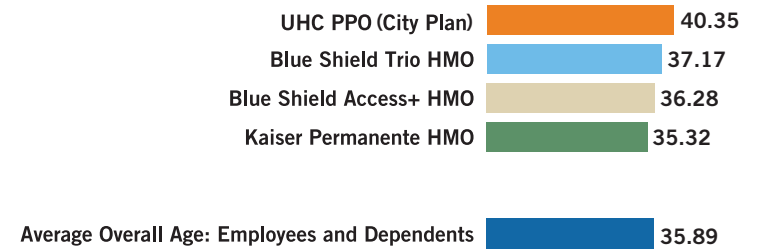
Medical Enrollment: Employees vs. Dependents



Medical Enrollment by Gender: Employees and Dependents



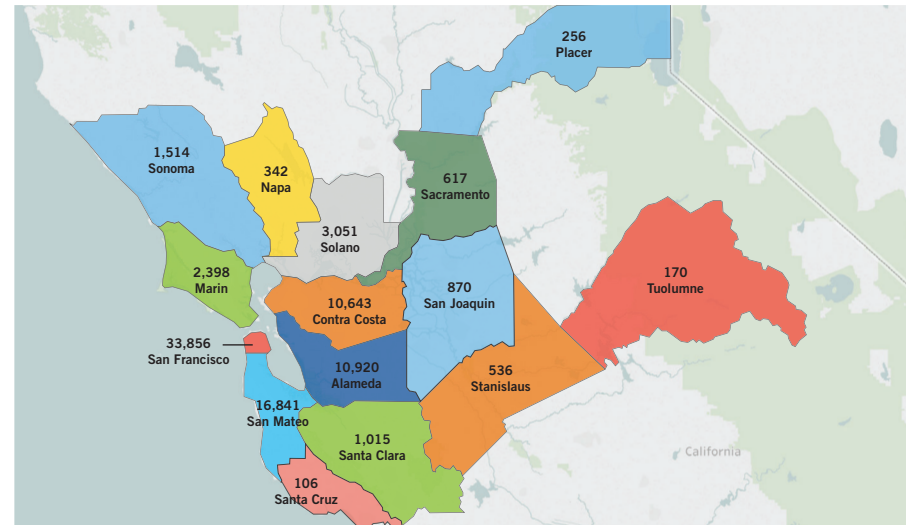
Average Age by Medical Plan: Employees and Dependents

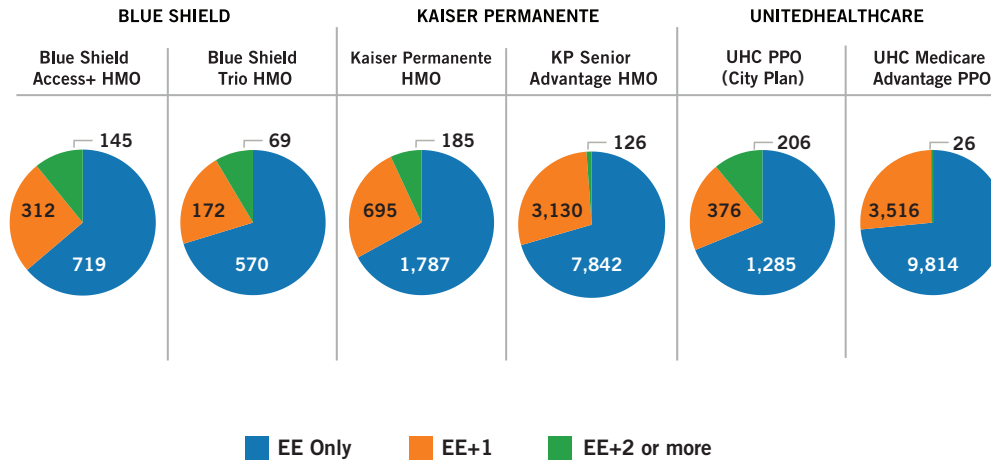

## Retiree Members and Dependents (All Employers)

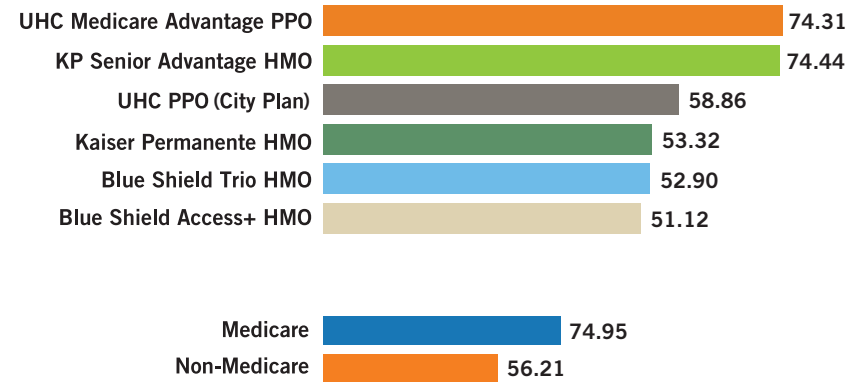
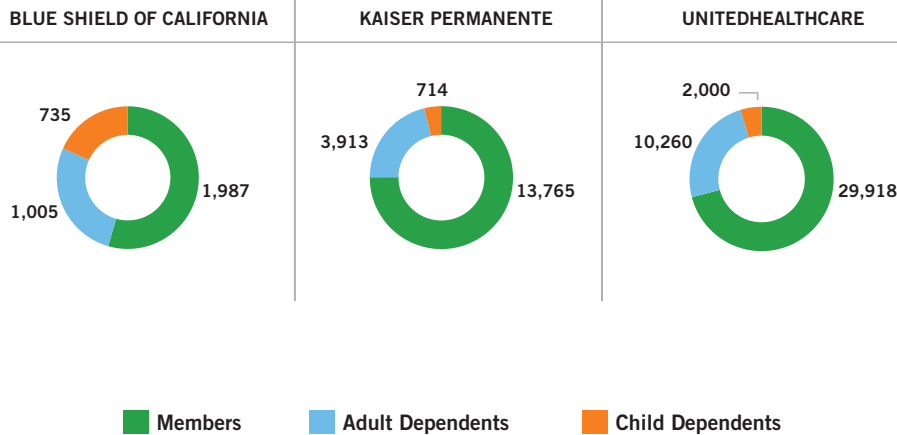
- Retiree lives continues an upward trend, increasing by another 854 lives to 40,265. Retiree members increased by 527 while retiree dependents increased by 327. Kaiser enrollments include 110 subscribers in regions outside of California; 40 in Hawaii, 42 in the Northwest and 28 in Washington. 2021 enrollment in the KP plans outside of California experienced a 25% increase.
- The proportion of retirees vs. dependents enrolled in medical dropped slightly to 74% retiree members and 26% retiree dependents.
- Medicare retirees remain split between UHC Medicare Advantage PPO with 55% and Kaiser Permanente Senior Advantage at 45%, as the prior year.
- The Blue Shield of California plans are only available for Non-Medicare retirees which accounts for the 6.6% of lives when taken as a percent of all retirees. When considering only Non-Medicare plans, the Blue Shield plans account for 36% of Non-Medicare retiree enrollment. The percentages have decreased from previous year.
- UnitedHealthcare City Plan PPO enrollment increased to 1,038 retiree lives which are comprised of Non-Medicare retirees, Medicare-eligible but not enrolled retirees or retirees living outside of the country.
- The average age of Medicare retiree lives enrolled in medical coverage is 74.95 and the average age of Non-Medicare retiree lives is 56.21. Enrollment decreased by 181 lives.
- The number of retiree members and dependents enrolled in coverage who reside outside of the United States is 54. 94 additional members live outside of the country but waive coverage.
- Retiree lives enrolled in Medicare increased to 30,716, an increase of 957. Non-Medicare retiree lives decreased by 103 to 9,549.
- 92% (37,098) of retirees and dependents enrolled live in the state of California. 88% live in Bay Area counties: San Francisco, San Mateo, Contra Costa, Alameda, Marin, Sonoma, Solano, and Santa Clara.
- 13,127, or 35% of retirees live in San Francisco.
- Enrollment in retiree dental plans increased by 572 lives, which demonstrates a steady increase in enrollment since 2017. A majority of retirees remain in the Delta Dental PPO plan with 31,175 or 92% of the total enrollment.

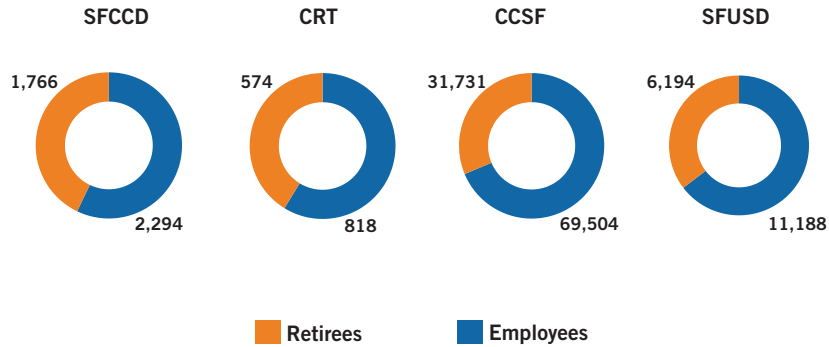

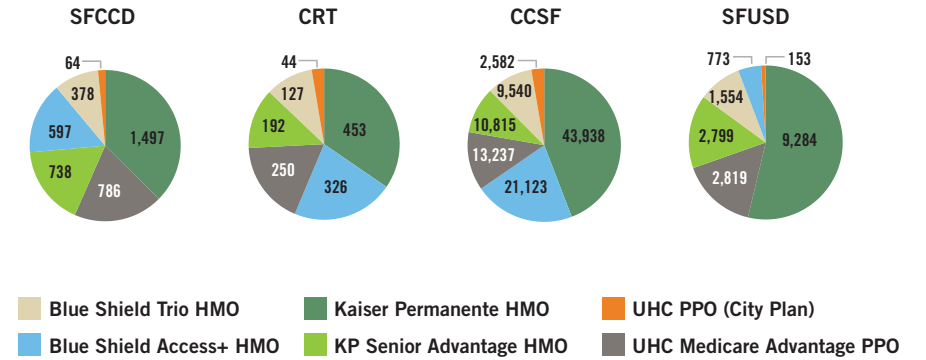
## Employers

- City and County of San Francisco covers the largest proportion of active and retiree lives at 81.6%. The San Francisco Unified School District covers 14.01%; City College of San Francisco covers 3.28% and the Superior Court of San Francisco 1.1%.
- The proportion of retiree lives to their total lives by employer is: City College of San Francisco at 43.5%, Superior Court of San Francisco with 41.2%, City and County of San Francisco representing 31.3% and San Francisco Unified School District with 35.6%.
- SFUSD has the highest proportion of employee lives enrolled in Kaiser Permanente HMO, compared to other employers. 80% of SFUSD, 58% for City and County of San Francisco, 48% of Superior Court employees, and 61% of City College of San Francisco employee lives are enrolled in Kaiser.
- For all employers, the average age of lives is highest for City College of San Francisco at 57.14 years and lowest for City and County of San Francisco at 45.58 years. The average age for the San Francisco Unified School District is 52.74 and the Superior Court of San Francisco is 51.79.
- City and County of San Francisco increased total number of lives enrolled in medical plans slightly to 101,235.

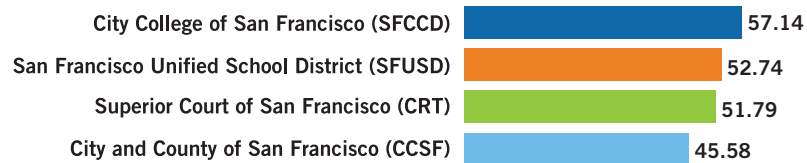
Medical Enrollment: Retiree vs. Employee Lives



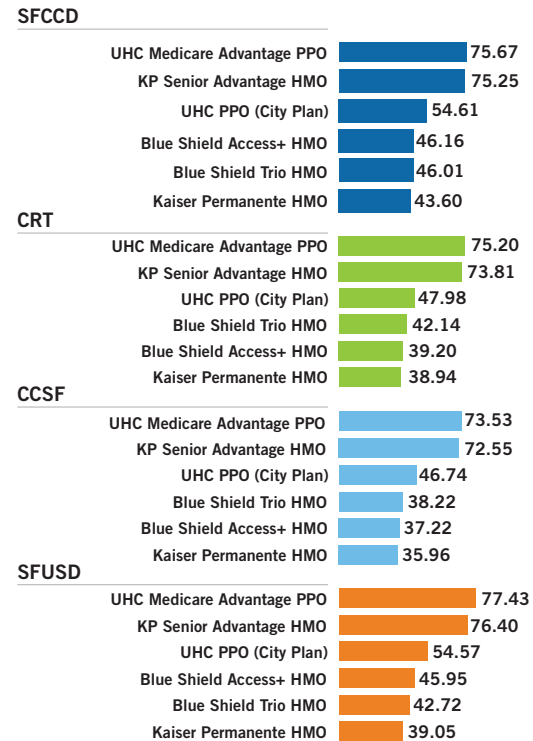
Medical Enrollment: All Lives by Employer

# GLOSSARY

---

- **Lives/Covered Lives:** The Plan subscribers (active and retired employees) and their covered dependents.
- **Employee Members:** The Plan subscriber who is an active employee.
- **Retiree Members:** The Plan subscriber who is a retired employee.
- **Retiree Non-Medicare:** Retired employee or their dependent who is not eligible for Medicare or eligible but not enrolled in Medicare.
- **Medicare Retiree:** Retired employee or their dependent(s) who is enrolled in Medicare.
- **Dependents:** Children, Spouse, Domestic Partner.
- **Member:** The Plan subscriber. When not itemized, this includes both active and retired employee.
- **Employers:** Four organizations whose health benefits are administered by the San Francisco Health Service System (SFHSS):
  1. **City and County of San Francisco (CCSF)**
  2. **Superior Court of San Francisco (CRT)**
  3. **City College of San Francisco (SFCCD)**
  4. **San Francisco Unified School District (SFUSD)**
