Express Dashboard Notes:

- All data is sourced from the All Payer Claims Database (APCD)
- Current dashboard is for incurred dates Jan 2017 – Dec 2017 with Paid through Mar 2018. The Diagnostic Cost Grouper (DCG) for risk scoring is based on the recent completed year of Jan-Dec 2017. The timing of the dashboard ensures there is a three month run-out so that there is not a huge decrease in spend between current and prior periods
- The risk scores presented are rescaled to the total population between the plans for the purpose of comparison. The annual presentation of risk scores is non-rescaled
- Risk scores may not always add up to a 100% due to members who are non-Medicare but may move to Medicare during the period
- Financials are not included in the Medicare Dashboard
- Measures identified as acute are those that take place in an acute inpatient setting. These include inpatient hospitals, birthing centers, inpatient psychiatric facilities, and residential substance abuse treatment facilities
- Total premium includes Best Doctors, Vision and the Healthcare Sustainability Fee

Key Observations:

- City Plan Non-Medicare population, despite an increase in subscribers which resulted in a lower risk score from the previous year, continues to be the sickest and costliest population as evidenced by various measures contained in the dashboard: High Cost Claimant Overview (p. 2), Cost and Utilization Trends (p. 4), Quality Markers (p. 5), Key Drug Metrics (p. 9)
- Specialty drugs comprise 14 of our 15 top drugs by cost
- 8 of the top 15 drugs are used for HIV infections and account for 18% of the total drug spend. SFHSS has 441 patients with an HIV diagnosis in the Non-Medicare population and 155 patients in the Medicare population
- Diabetes is our 3rd most prevalent chronic condition and the costliest. There are 3,827 patients in our Active/Early Retiree population and 4,001 patients in our Medicare Retiree population
- Autism is now our top mental health episode by cost with 214 patients ranging in age from 1 – 49. Autism advocates have tried to frame Autism as a developmental / neurological disorder however it is still considered a mental health disorder and the largest number of patient visits to a specialty physician are to psychiatrists

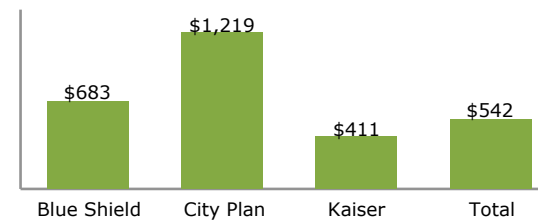

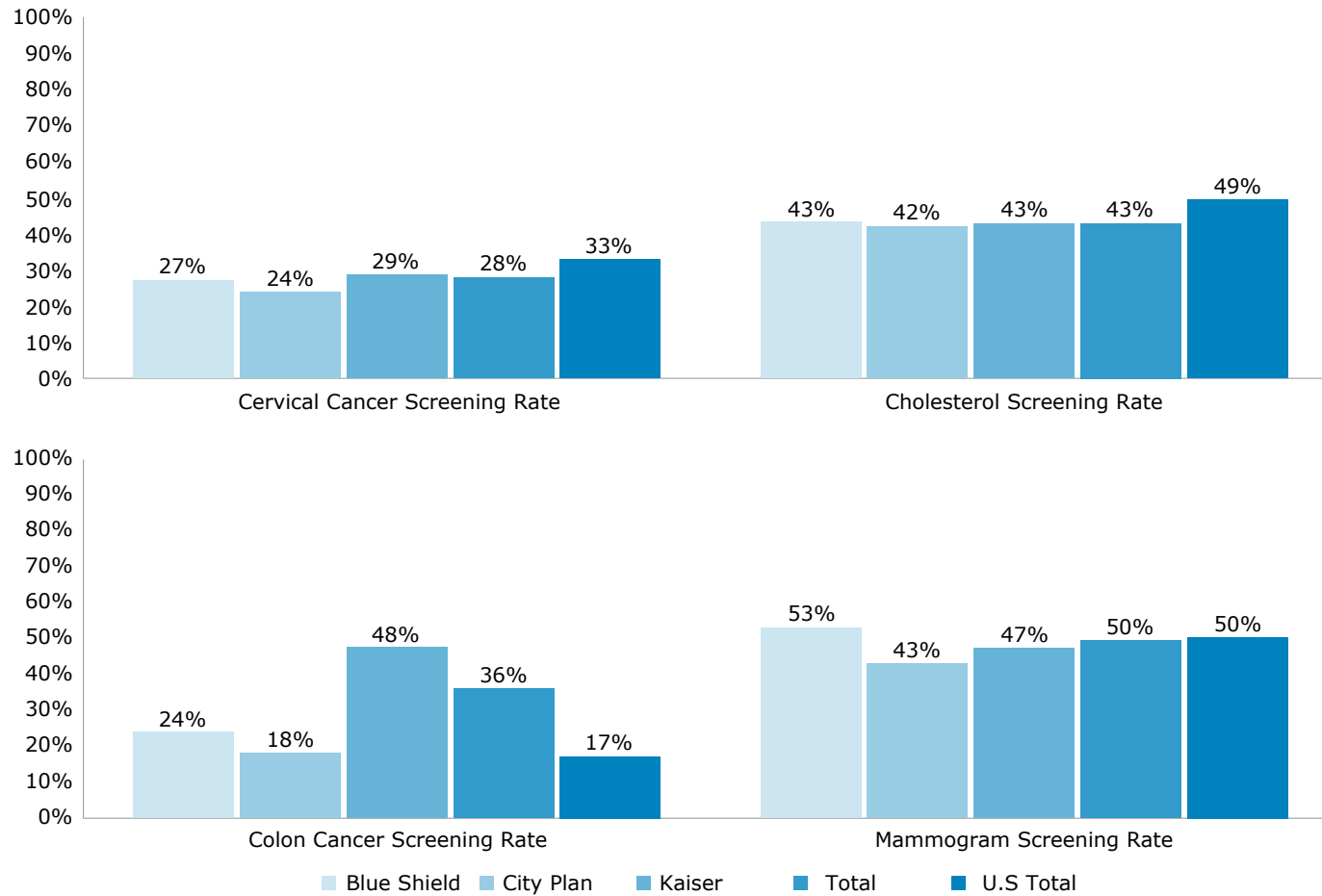

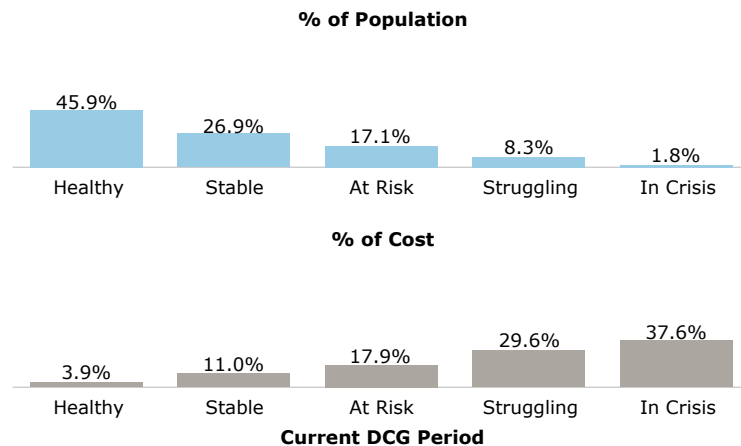

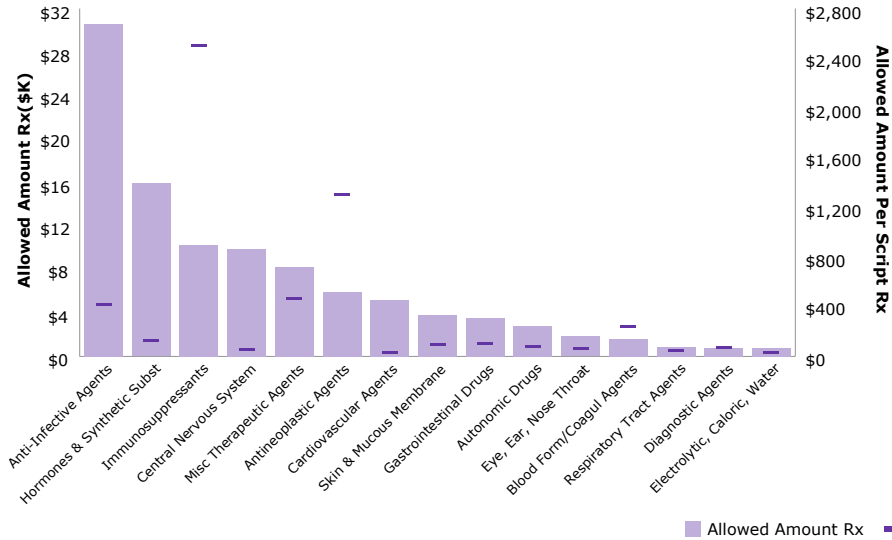

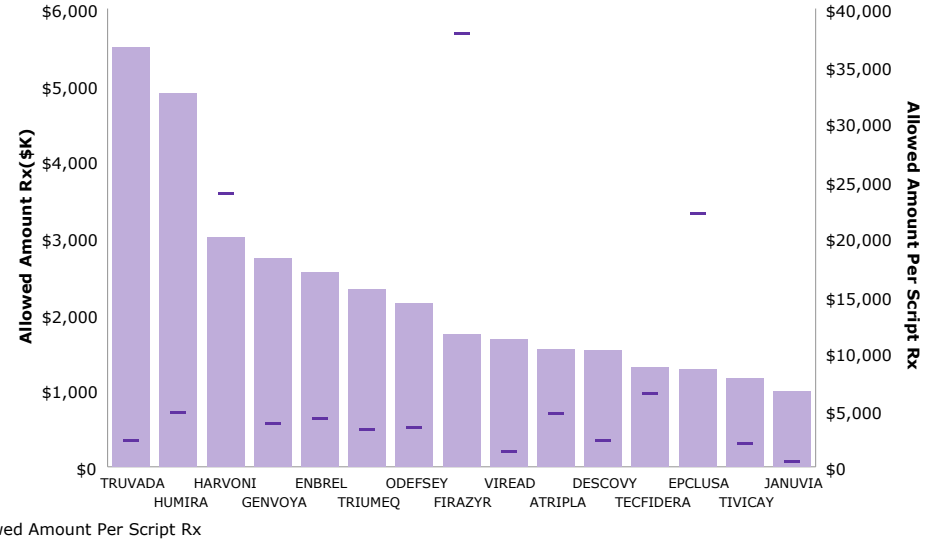

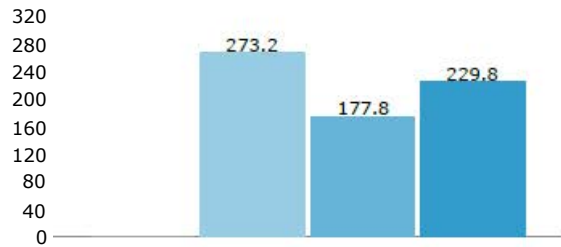

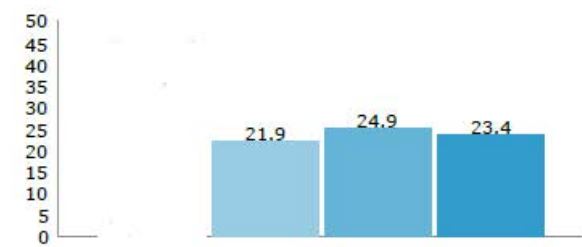
Chronic Condition Prevalence



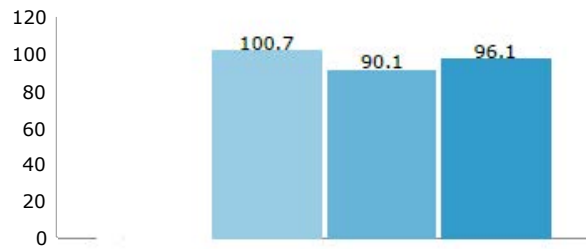
Hypertension Patients per 1000



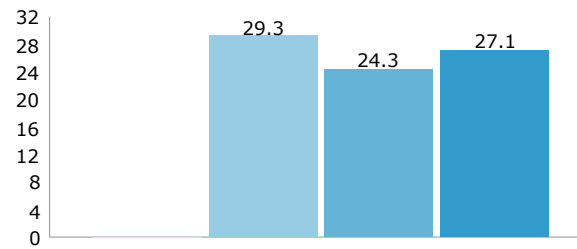
Diabetes Patients per 1000

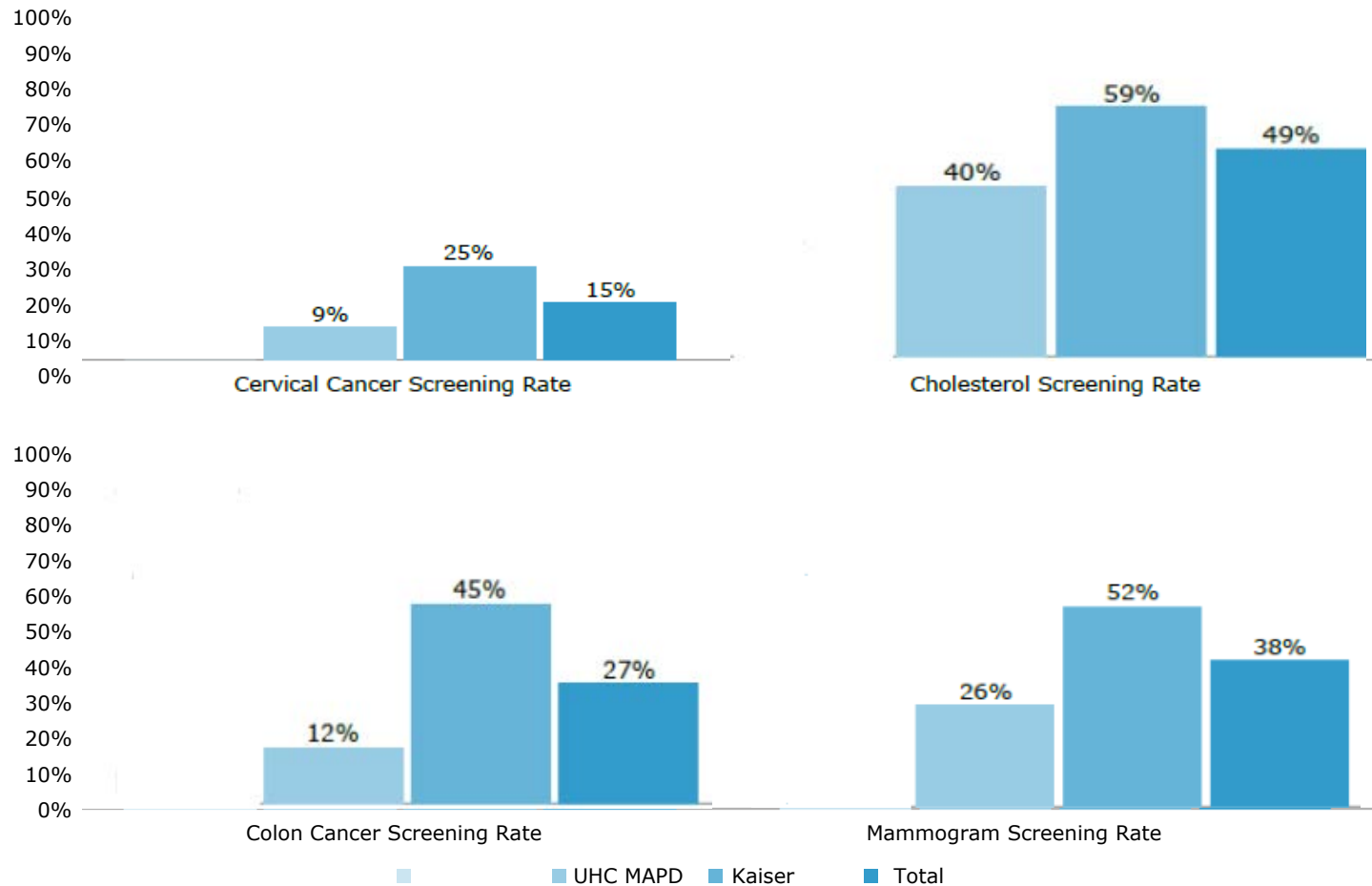

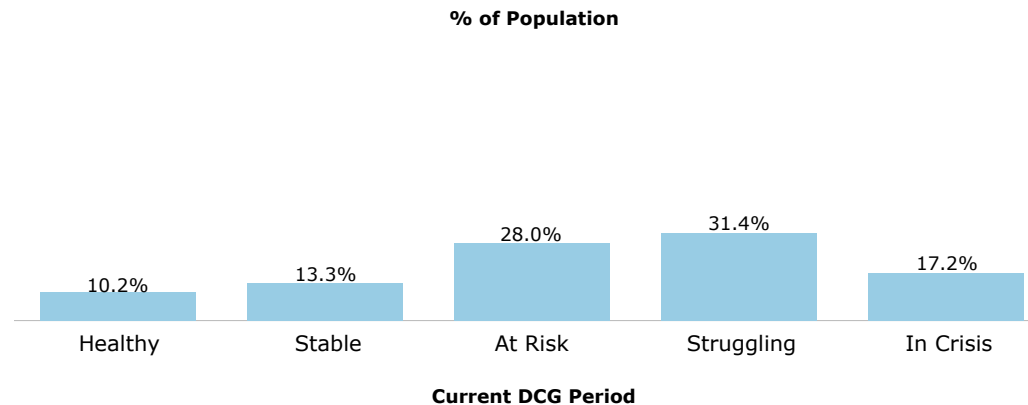
