# SFHSS EXECUTIVE DIRECTOR RETIREMENT

### **HEALTH SERVICE BOARD 2025 ELECTION**

A Health Service Board election will take place in May 2025. The Department of Elections (DOE) will conduct the election. The Board Secretary is collaborating with the City Attorney's Office and DOE. The 2025 election will include one elected member seat elected by the active and retired members of the SFHSS for the term from June 2025 - May 2030. Under the Charter Section 12.200 and San Francisco Administrative Code Sections 16.550 – 16.554, whenever the term of office of an elected member expires, an election must be held to fill the vacancy. The election practices begin on January 9, 2025, when the election resolution, notices, nominee forms, and the election fact sheet are available for all SFHSS members to download from our website or pick up in our offices. Election updates will be shared throughout the process.

# ETHICS COMMISSION NEW LAWS AND REGULATIONS EFFECTIVE OCTOBER 12, 2024 City officers, employees, and certain City & County of San Francisco consultants are subject to state and local ethics and conflict-of-interest laws, disclosure and training requirements, and restrictions while employed with the City. In addition, certain activities are restricted post-employment. The San Francisco Ethics Commission provides more information on local ethics laws, disclosures, and training requirements.

### HEALTHCARE AFFORDABILITY BOARD AND ADVISORY COMMITTEE

The Health Care Affordability Board is a decision-making body charged with setting statewide and sector-specific spending targets, appointing a Health Care Affordability Advisory Committee, and approving key benchmarks, such as alternative payment model adoption and the share of spending dedicated to primary care and behavioral health, among other responsibilities. Board members may not receive compensation from healthcare entities.

# **HUMAN RESOURCES:**

### **PERSONNEL**

# **FINANCE AND BUDGET:**

- Budget planning is in process. The mayor has set a 15% cost reduction target, translating to \$600K for HSS.
- As stated in the HSF budget presented at the February 2024 meeting, the Merative All Payers Claims Database (APCD) contract will end on December 31. 2024. This will provide \$100K in savings to the Health Sustainability Trust.



### **CONTRACTS:**

- Executed second amendment for Unitedhealthcare ASO PPO 2024 claims runout.
- Executed amendment to agreement with CredibleMind for mental health and well-being resources.
- Issued competitive bid for life and disability benefits for the 2026 plan year.
- Completed Medicare secondary payer attestation for Kaiser Permanente.

# **WELL-BEING:**

- Partnering with DHR to build online training for First Responder EAP services through the eLearning platform.
- In partnership with Kaiser Permanente, 1,700 flu vaccines were administered.
- Completed the last Working While Black Healing Circle cohort of 2024, with 56% indicating connecting with others with similar interests and 44%. This indicates receiving resources and tools during the healing process is helpful for participants in the healing circle.












# SFHSS Website Engagement
