Committee Chair Breslin noted that agenda item number six, REPORTS AND UPDATES FROM CONTRACTED HEALTH PLAN REPRESENTATIVES is not required for this meeting and will not be called.

Larry Loo, Chief Financial Officer, Larry Loo presented the following items:

Larry Loo, Chief Financial Officer reviewed with Commissioners the Mayor's Budget instructions which include priorities for the City and County departments with a priority to support small businesses and the economic recovery with demonstrated outcomes centered on equity. Larry Loo stated the Mayor's Instructions include a target reduction of 7.5% across all departments and the Mayor's office identified continued reductions in case City revenues decrease further; for the Health Service System mandatory target reductions were \$273,012 and \$91,004 for the contingent reductions each year. Larry Loo also reminded the Board that the fiscal budget is set on a biennial basis, so the budget includes a two-year projection. Larry Loo reviewed the General Fund summary and outlined the budget within personnel, non-personnel, materials and supplies, work-orders and interdepartmental services.

Larry Loo identified the largest cut to meet the Mayor's Budget instructions was the elimination of the 24-hour Employee Assistance Program (provided by ComPsych). Larry Loo noted this program was implemented at the Mayor's request in April 2020 at the beginning of Shelter-in-Place and is actively utilized by employees.

Commissioner Hao asked to summarize all of the proposed cuts to meet the Mayor's Office requirements. Larry Loo recapped the nature of the reductions on the presentation and highlighted the largest proposed reduction is the ComPsych 24-7 Employee Assistance Program and although it was identified as a cut, the budget proposal will ask that the program be restored.

Commissioner Hao asked to clarify if the base budget number is adjusted for any proposed cuts in the first year. Larry Loo stated the target reduction for both years is \$273,012 of the base budgets already in the budgeting system.

Vice President Canning asked if there is a way to modify the ComPsych contract to reduce the overall cost. Larry Loo said the cost can be negotiated during the contract process, but the budget estimate is based on the current rate as it sits today. Vice President Canning asks if the hope is that the Mayor's Office will return the program by finding other funding sources. Executive Director Yant shared that a similar dilemma occurred last year and after working with the Mayor's office the department successfully received funds. Executive Director explained that the program was not meant to erode the core services of the Health Service System and the Employee Assistance Program costs need to be covered by City funds. Executive Director Yant also added that mental health is a key priority for both the Mayor and the Board of Supervisors. Commissioner Hao asked if the program is restored is there a risk that other areas of the budget will be removed. Executive Director Yant said any further cuts would force us to recommend layoffs which the Mayor's office explicitly instructed not to do. Commissioner Hao agreed layoffs would be the absolute last resort and not something anyone wants to consider.

Vice President Canning moved to approve the proposed San Francisco Health Service System Fiscal Year 2021-22 and Fiscal Year 2022-2023 Proposed Budget General Fund Administrative Budget as presented. Commissioner Hao seconded the motion.

Larry Loo, Chief Financial Officer, Larry Loo presented the following items:

Chief Operating Officer, Larry Loo explained the Healthcare Sustainability Fund budget is funded by the \$3 per member per month fee from those enrolled in the HSS health plans, and the budget funds are used to disseminate information to members about their benefits especially during open enrollment, fund member well-being programs, cover actuarial costs and expenses that reduce the cost of healthcare. Larry Loo further explained that in the last few years, the average expenditure has been less than the revenues which creates a surplus and that surplus is carried over to the next year. Larry Loo noted the Healthcare Sustainability Fund allowed for one-time expenditures such as the Voice Over Internet Protocol (VoIP) system, website re-design, and

audit services. Larry Loo called attention to the two major budget requests: in 2021-2022 add two full-time employee project staff positions and in 2022-2023 one full-time employee to support the open enrollment.

Commissioner Zvanski asked if there could be a deficit and how that would be resolved. Executive Director Yant clarified that the fund can not reach a deficit. Executive Director Yant noted the department has reviewed the last 5 years past and forecasted 5 years to project any adjustments to the fund. Executive Director Yant reminded the Board that the Healthcare Sustainability Fund is not approved by the Mayor or the Board of Supervisors.

Commissioner Hao moved to approve the proposed San Francisco Health Service System Fiscal Year 2021-22 and Fiscal Year 2022-2023 proposed Healthcare Sustainability Fund Budget as presented. Vice President Canning seconded the motion.
