Chair Follansbee stated the Health Service Board's 100% was conducted by the six current Board members. The full Board is composed of seven members and the Board of Supervisor appointment seat is vacant. Chair Follansbee noted results were not reported for the question "Board carefully deliberates before taking action," in Table two on slide seven. The correction will appear in the final document.

The three items were pulled from the comments to consider as areas to focus on for 2022.

- 1. Broaden the educational platforms to include conferences and invite more speakers.
- 2. Remind Commissioners to stay on topic during discussions.
- 3. <u>Clarify questions #24, #27, #34, and #38 at a future Governance Committee meeting prior to issuing the 2023 Annual Board Self-Evaluation Questionnaire.</u>
  - #24-The Board communicates effectively to Plan Members.
    - Chair Follansbee noted the marked improvements in the effectiveness of communication to plan members through better documentation of communication. The Committee agrees the strategy is through the Health Service System. Commissioner Zvanski asked if the Health Service System communicates with City unions. Executive Director Yant said the City Unions are considered stakeholders and the department communicates with the City Unions as the need arises.

#27-The Board communicates effectively to the City.

 Commissioner Scott said the Board has communicated to the City via letter to the Board of Supervisors or the Mayor. Executive Director Yant said the Health Service System communicates the annual budget and the Rates and Benefits are sent to the City on behalf of the Board. Chair Follansbee said the word effectiveness could be clearly defined.

#34-The Board ensures management has the necessary financial and human resources to achieve the organization's goal.

 Chair Follansbee suggested the question be separated into two questions: financial resources and human resources. Commissioner Scott suggested the question focus on the Board ensuring management has the necessary financial and human resources to achieve the organization's goals through the budget process.

#38-Where feasible, the Board engages in effective management succession planning.

 The Committee agreed the Board only engages in succession planning for the Executive Director. Executive Director Yant said her role involves succession planning for staff which could be included in the annual performance employee evaluation, so the Board is informed of management succession planning.
