# 3. <u>REVIEW AND APPROVE RESULTS AND DRAFT REPORT OF THE ANNUAL BOARD SELF-EVALUATION FY 2019-2020: (Action)</u>

Board Secretary, Holly Lopez presented the following items in the Annual Board Self-Evaluation FY 2019-2020 Report Draft:

- Improvements in Areas of Possible Concern in the 2018-19 Evaluation
- Summary of Areas that Showed the Most Significant Score Increases
- Results of Board Performance
  - Evaluation of Governance Structure & Policies
  - Board Member Interactions and Meeting Activities
  - Evaluation of Goal Setting and Communications
  - Assessment of the Board's Interaction with Management

Committee Chair Scott thanked Holly Lopez for her effort and her work completing the report for the Board. Holly Lopez, Board Secretary, thanked the Board for the opportunity to work on the evaluation and see the depth and scope of the reflective practices and the Board's work and time spent completing the process, including completing the survey by the due date.

Holly Lopez reviewed the Executive Summary with the Committee. Holly Lopez noted the total score showed improvement in two of the four areas, stabilization in one area, and a decrease in one area. Holly Lopez stated there were 36 questions total, spread across the four sections, 19 out of 36 statements in the evaluation showed increased ratings from last year, 11 statements decreased, 6 ratings stayed the same.

Holly Lopez noted the average score shift was driven by a significant number of "Strongly Disagree" responses by one respondent and upon closer look at the comments this respondent did not make any suggestions, express any confusion or rationale to the disagreement, in fact, the respondent only offered positive comments. Holly Lopez suggested this may have been an error in the respondent's marking to the questions.

President Follansbee commented that the report narrative was very clear and suspected that where there was a "strongly disagree" response, the respondent may not have been marked as intended. Commissioner Zvanski agreed that the positive comments indicate affirmative response and the marking may have been misunderstood by the individual respondent.

President Follansbee noted that the survey tool did not allow a respondent to go back to a previous section to review their responses. Commissioner Zvanski recalled the same inability to review her responses. Chair Scott asked Holly Lopez to check the survey tool capability and note the option in the full report and when presented to the full Board.

Holly Lopez reviewed the following four sections of the evaluation outcomes with the Board

- Evaluation of Governance Structure & Policies
- Board Member Interactions and Meeting Activities
- Evaluation of Goal Setting and Communications
- Assessment of the Board's Interaction with Management

Holly Lopez noted two comments in the Governance Structure and Policy section, one comment requested more subject matter experts for Board education training sessions and another comment suggested more opportunities for external training.

President Follansbee asked if there were any comments on the question, "The Board focuses on policy and strategy in addition to operations." Holly Lopez shared the comment, "The Request for Proposal (RFP) process required hindsight review to understand how the HSB had impacted and influenced the RFP. The role of the HSB in the RFP process could have been better outlined as the RFP rolled out. The HSB also continues to struggle with how the Five Areas of the Strategic Plan are being addressed by each item for action and how the actions further the implementation of this Strategic Plan." Chair Scott noted the Governance Committee met in November and discussed the RFP process to set the groundwork to prepare for future RFPs. Chair Scott also requested this survey question and comment be pointed out in the full Board presentation.

Holly Lopez stated the Board Member Interactions and Meeting Activities section score remained stable. Holly Lopez noted two comments expressed the need to remind the Board of its fiduciary responsibilities. Erik Rapaport, General Counsel with City Attorney's Office, reminded the Board that the Fiduciary Standards and Board Member Roles presentation is posted on the Board website. Erik Rapoport also pointed out that the applications of the standards is can be complicated because there are not many public sector commissions similarly situated as the Health Service Board. Chair Scott wondered if a broader fiduciary responsibility training is available and relate specifically to the public sector or non-profit sector. Commissioner Scott also mentioned the use of a consulting firm to offer training. Commissioner Zvanski recommended the fiduciary training through the International Foundation for Employee Benefits, which all Board members have access to as HSB Commissioners. Commissioner Zvanski also recommended a firm used for previous trainings. Chair Scott recommended an annual review and training of the Board's fiduciary responsibilities. Karen Breslin agreed with Chair Scott and commented that the training would focus on the Board's responsibilities in addition to the fiduciary standards. Karen Breslin also commented that the training would complement the City's conflict of interest training. Erik Rapoport said he would look into the possibility of having and outside consultant provide fiduciary training.

Holly Lopez noted the overall score increased for the Goal Setting and Communications section. Chair Scott recalled Open Enrollment communication plans shared with the Board and asked Executive Director Yant if more broad communication plans could be shared throughout the year. Executive Director Yant stated that Member communications are critical to SFHSS operations and the department funded the Director of Communications role last year which brought Jessica Shih to the team last February. Executive Director Yant shared during the last year Jessica learned the 1145 MARKET STREET 3<sup>RD</sup> FLOOR, SAN FRANCISCO, CA 94102

department operations, quickly pivoted to the virtual world, increased the utilization of the website, and brought on an intern to look at the website user interface. Executive Director Yant stated that part of Jessica Shih's work is developing an overall communications plan and she can present the plan to the Board. Commissioner Zvanski expressed her appreciation for the communications effort and recognized the significance of the Communications Director role in the department and for the communication to Members.

President Follansbee noted the SFHSS website offers information about the Board, but it would be good to review the content. Commissioner Zvanski agreed it would be good to describe the Board's work but described the challenge to inform more people, especially since many people don't actively seek service unless they are experiencing a direct need. Commissioner Scott suggested the Communications Director also review the Board webpages. Executive Director Yant stated that Jessica Shih can help clarify our key messages and ways to deliver across multiple avenues, including the website.

In conclusion, Holly Lopez stated that although no outstanding issues surfaced from this evaluation, the Board can continue to improve by focusing on areas including:

- Diversifying Board education resources
- Providing Regular Strategic Plan updates at Board meetings and notations on Board agendas
- Creating a timeline of how the HSB will be involved in the future Request for Proposal Process
- Offering an annual fiduciary responsibility review by Counsel

Chair Scott requested the second bullet point be divided into two: Providing Regular Strategic Plan updates at Board meetings and Providing Strategic Plan notation on Board agendas.

President Follansbee moved to accept the Health Service Board Annual Self-Evaluation Report with modifications. Commissioner Zvanski seconded the motion.

PUBLIC COMMENT: None

ACTION: The Health Service Board Governance Committee unanimously approved the Annual Board Self-Evaluation FY 2019-2020 Report Draft as discussed and modified for a referral to the Full Board in February 2021.

Board Secretary, Holly Lopez presented the following items in the Board Education Report Draft:

Chair Scott stated the Board Education report has been conducted for four or five years and in accordance with the Strategic Plan, has integrated Education opportunities into the Board's work.

Chair Scott also stated that November Board meeting is held as an Education Forum with additional education resources offered and conducted both internally and externally throughout the year.

Holly Lopez thanked the Board members for completing the Board Education Topics survey that ranked six educational topics in order of interest. Holly Lopez, Board Secretary noted the following 2020 education offerings: In April- a four-part Non-Medicare Healthcare Plan Rating Methodology, in November a Medicare Market Update, and December-Health Insurance Portability and Accountability Act (HIPAA), Board also approved the Phase I SFHSS Racial Equity Action Plan (REAP) accompanied by a joint SFHSS staff presentation on the Social Determinants of Health (SDoH).

Holly Lopez noted the survey results shared three additional topics from Board members: (1) fiduciary responsibility refresher, (2) social determinants of health (SDoH), and (3) health plan transparency cost. Holly Lopez clarified that the SDoH was not listed as an option because it will be included as part of the new Racial Equity Action Plan and the fiduciary responsibilities will also be included in light of the Annual Board Self-Evaluation results. Chair Scott requested the health plan transparency cost included in the 2021 Board Education topics to be covered as it relates to the impact of premium rates. Executive Director Yant agreed health plan transparency cost be included. Chair Scott also suggested the following sentence modification: "The REAP presentation was accompanied by a joint SFHSS Staff presentation on the Social Determinants of Health (SDoH) that highlighted the overview of disparities from the national, county, and SFHSS membership perspective with an emphasis on whole-person health and well-being." Chair Scott also requested the report list the survey results more clearly, just as in the presentation.

President Follansbee moved to accept the 2019 HSB Education Report with modifications as discussed. Commissioner Zvanski seconded the motion.

PUBLIC COMMENT: None

ACTION: The Health Service Board Governance Committee unanimously approved the 2019 HSB Education Report with modifications as discussed.

Commissioner Zvanski supported the change so long as the language offers non-Board members such as members or provider representatives, to make public comments.
