Vice President Hao said this special meeting of the Health Service Board is convened because the Board rejected the staff's recommendations for the RFP for Blue Shield of California's new Medicare Advantage PPO plan and also rejected the renewal of UHC's MAPD PPO plan. Both items are reconsidered as the charter mandates the Health Service Board to adopt plans for retirees. She said that agenda item 3 is the staff recommendation for the Blue Shield of California plan. The following UHC item will be rendered null and unheard if the Board approves the staff RFP recommendation. If it doesn't pass, we will proceed to the UHC item.

Vice President Hao said public comments will be limited to one minute to ensure everyone has a chance to speak. Public comment is for expressing opinions and concerns, not for engaging in Q&A with the staff or Board members.

Vice President Hao announced that the newest member of the Health Service Board, Dr. Fiona Wilson, is the Chief Physician for the City and County of San Francisco Employees within the Department of Human Resources. Commissioner Wilson shared her specialty as an internist with approximately 20 years of experience as a practicing physician with UCSF and in a leadership role at Brown and Toland Medical Group. Commissioner Wilson said she was hired by the City as the Chief Physician four years ago, during the onset of the COVID pandemic. Commissioner Wilson said her focus is on serving and listening to the needs of our active employees and retirees.

Abbie Yant, SFHSS Executive Director, Michael Visconti, SFHSS Contract Administration Manager, and Mike Clarke, Aon, welcomed questions from the Board. Commissioner Zvanski asked how 1145 MARKET STREET 3<sup>RD</sup> FLOOR, SAN FRANCISCO, CA 94103

many retirees will be impacted if the staff recommendation for the MAPD Passive PPO plan is approved. Mike Clarke, Aon said about 17,000 who are Medicare plus 1,000 non-Medicare covered lives would be transitioned from the United Healthcare to the Blue Shield of California administrator. Executive Director Yant said member details are listed in the February annual demographics report presented to the Board.

Supervisor Dorsey moved to accept the staff recommendation of the Medicare Advantage Prescription Drug Passive PPO for the 2025 plan year. Commissioner Wilson seconded the motion.

#### Written Public Comment

The Board Secretary noted over 400 written public comments received by the deadline, all of which were sent to the Health Service Board Commissioners.

Patrick Monette-Shaw: The action this Health Service System Board took during today's meeting with one Commissioner absent should be declared null and void. One speaker — retired San Francisco Police Sergeant Liana DeWitt — testified prior to your four-to-two vote on today's motion on agenda item 3 to reconsider the Board's June 7 vote rejecting Blue Cross of California to be awarded the HSS Medicare Advantage PPO plan contract was improper. DeWitt asserted today's Agenda Item 3 was essentially performing a "*de facto reconsideration*," which can't be done at a later, subsequent meeting. A vote for reconsideration had to have been taken at the initial original meeting on June 7. So this Board's action today to pursue this vote was a "*de facto rescission*," which is illegal. I believe DeWitt is correct this vote will likely subject all of you open to legal challenge, and probably expensive litigation involving an illegal vote.

Supervisor Dorsey expressed his support for the staff recommendation, emphasizing his belief in the integrity of the thorough and meticulous competitive bidding process. Supervisory Dorsey said it is his fiduciary duty to honor the RFP process and, having reviewed the comprehensive 80-page presentation, found no evidence of harm to the delivery of care. He highlighted the broader context of budget constraints, asserting that this decision will not negatively impact the care provided to people. Supervisor Dorsey pointed out the high inflationary costs in the healthcare system and argued that a competitive bidding process is essential to managing these costs. He stressed that rejecting the best bid after such a thorough process would undermine the purpose of competitive bidding. The speaker reaffirmed his support for the staff recommendation, acknowledging that their decision may not please everyone, and stood by his conscience in supporting the recommendation.

Commissioner Zvanski said she would vote in favor of the members.

Commissioner Sass believed Blue Shield could manage the Medicare Advantage PPO as effectively as United Healthcare. He pointed out that the City Charter outlines retiree medical coverage and emphasized the significant financial savings for the City, as most of the premium costs are covered by the City, not the members. Commissioner Sass highlighted that the RFP process was fair, with all respondents aware of the scoring criteria. United Healthcare did not offer price concessions, projecting future costs to rise at the same rate as in the past. Commissioner Sass said he supported replacing UHC with Blue Shield based on the RFP results.

Commissioner Howard said his biggest fear is for the thousand dependents without Medicare who may struggle to find a Blue Shield or Blue Card provider, especially those living in remote areas, hoping the Health Service System can assist them.
