Providing Public Comment tips and instructions once you have dialed in:

After entering the access code, press # to listen to the meeting (There is no delay when listening to the meeting using this number.)

Instructions Regarding Providing Public Comment:

1. DIAL the Toll-Free number listed above for the meeting.
2. Enter the ACCESS CODE listed above then press #.
3. Press # again to join the meeting as a participant.
4. When you hear that "you are connected to the meeting as a participant":
 - a) STOP and LISTEN TO THE MEETING
 - b) Wait for Public Comment to be announced (either by item # or under New Business)
5. When the Commission Secretary calls for PUBLIC COMMENT, dial '1' then '0' to be added to the speaker line.
6. When the system message says your line is unmuted, provide your comment after the tone [BEEP] – THIS IS YOUR OPPORTUNITY TO PROVIDE YOUR PUBLIC COMMENT (this is not a question-and-answer period, this is your time to provide a statement).
7. You will have 3 minutes to provide your comments.
8. Once your 3 minutes has ended, you will be moved out of the speaker line and back to listening as a participant in the meeting.
9. Participants who wish to speak on the other items on the agenda may stay on the meeting line for future agenda items.
