### 3. INITIATE PUBLIC EMPLOYEE EVALUATION PLAN YEAR 2021: (Action)

Presented by Committee Chair Scott

Governance Committee Chair Scott presented the Board annual Employee Performance Evaluation for the SFHSS Executive Director for the plan year 2021. Committee Chair Scott stated that Employee Performance evaluates five areas of performance, and the same format has been used for at least five years. Executive Director Yant confirmed that the 2021 evaluation will be her 3<sup>rd</sup> evaluation. Chair Scott noted last year the Committee made some wording modifications last year.

Committee Chair Scott introduced the Public Employee Evaluation timeline beginning with the full Board's approval in November 2021 and concluding in March 2022 in which the results will be shared in a closed session before the full Board. Commissioner Scott reminded the Committee that surveys are also completed by the Health Service System's Chief Operations Officer (COO) and Chief Financial Officer (CFO). Chair Scott asked Executive Director Yant if other staff reports directly to her. Executive Director Yant said Holly Lopez, Board Secretary, and Leticia Harris-Senior Health Planner report to her directly and Michael Visconti-Contracts Manager, jointly reports to her and the CFO. Chair Scott recalled the Committee's discussion last year to include more staff participation, and the Committee decided only the CFO and COO needed to complete the survey.

Commissioner Zvanski moved to adopt the employee evaluation survey and timeline for the plan year 2021 as presented. President Follansbee seconded the motion.

### 4. INITIATE ANNUAL BOARD SELF-EVALUATION PLAN YEAR 2021: (Action)

Presented by Committee Chair Scott

Governance Committee Chair Scott presented the Board Self-Evaluation survey. Chair Scott said there are several areas of activity that the Board reviews with a total of forty questions. Chair Scott noted several questions were modified last year and asked if Committee members had any further survey question modifications this year. President Follansbee and Commissioner Zvanski said they had no edits to the survey questions.

Chair Scott presented the timeline and pointed out the Evaluation will begin in November with the approval of the full Board. Committee Chair Scott introduced the agenda item with a reminder that the Governance Committee is responsible to oversee Health Service Board policies, upon which the Board adopted the Governance Policies and Terms of Reference on February 22, 2007, amended on April 9, 2015, and further amended on February 19, 2019. Chair Scott stated policies are reviewed at least once every three years to ensure the Governance Policies and Terms of Reference remain relevant and appropriate. Chair Scott stated the attached document presents the timeline for the reviewal process. Chair Scott explained the review process will include a page-by-page review to address any changes. Chair Scott presented the timeline and said the full review is scheduled for December 2<sup>nd</sup>, after which it will go before the full Board for approval and subsequent publication on the Board's website.
