Commissioner Follansbee applauded all the health plans for the COVID case numbers and reminded members to complete the entire series of vaccination shots to have full protection. Commissioner Follansbee shared that Paxlovid prescriptions shorten the course of the virus, improve the risk of spread, and may also have a positive impact on the long COVID symptoms. Commissioner Follansbee wondered what adherence the health plans have for the use of Paxlovid. He also complimented Kaiser Permanente for updating information for members to urge them to contact their providers if the Paxlovid prescriptions are appropriate for individual needs.

Commissioner Follansbee asked what the impact on the Health Service System is with so many staff vacancies. Executive Director Yant said the department remains highly functional. Executive Director Yant said there are always some vacancies, and several things impact the timeframe: the time it takes to hire new staff, evaluate if the position is the right one for the department, and consider adjustments in classifications. She said the department is well on the way to hiring in priority order.

President Scott commended the staff for their collective and individual work on Open Enrollment with efforts compounding improvements each year like eBenefits.

Iftikhar Hussain, SFHSS's Chief Financial Officer introduced the item. Craig Harner and Yia Yiang, MGO presented the item.

Craig Harner thanked the management and staff for their work to complete the audit report and respond promptly to all questions. President Scott requested an additional bullet point be added on slide 2 to indicate there were no compliance deficiencies. President Scott said the annual audit report offers background, history, and outline of the governance structure for this process and recommended members and the public read as references for this process.

Commissioner Canning moved to approve the audit report with edits. Vice President Hao seconded the motion.

#### 10. SUTTER HEALTH SETTLEMENT DISTRIBUTION APPROVAL: (Action)

Abbie Yant, SFHSS's Executive Director introduced the item and Iftikhar Hussain SFHSS's Chief Financial Officer presented the item.

• Approval for Use of Settlement Distribution and recommendation

Abbie Yant said the Health Service System received the settlement funds and a second payment is expected in 2023. Abbie said the management team consulted with the City Attorney's office, the Aon actuarial team, and third-party attorney advice to bring the recommendation. Iftikhar Hussain announced Emma Hoo, Purchaser's Business Group on Health (PBGH) was involved in the case over the last 10 years and is also available to answer questions. Iftikhar noted corrections to the original recommendation as follows:

- Total and the correct amount is up to \$17.5 million. The amount is a combination of the first \$14.7 million payment and the expected second payment to come in in March 2023. The second payment will be a true-up so it could be more than \$2 million so the action is for the \$17.5 million.
- Replace the words "rate stabilization" with "underwriting rate setting process" since the stabilization process has specific rules such as 3-year amortization which may be applicable to legal settlements.

Commissioner Breslin noted members under the former United Healthcare City Plan may have used Sutter Health doctors and those members now have Blue Shield of California. She asked if the distribution would change the rates for the Blue Shield of California members. Commissioner Follansbee said the lawsuit involved the Sutter Health hospital system, so it wouldn't affect individual physicians' billing. Iftikhar Hussain said the Health Service System submitted claims that were eligible under the class action suit regardless of who administered the benefits. Emma Hoo said the lawsuit was specifically based on the hospital claims that were submitted by the carriers between a period in 2003 to 2016. Emma Hoo said the lawsuit did not cover Medicare Advantage, only commercial self-funded or flex-funded plans. Abbie Yant acknowledged Commissioner Breslin's question about the impact on rates and reassured the Board that any rate changes would be brought before the Board during the rate-setting process in 2023.

Commissioner Canning moved to approve the use of the entire distribution up to \$17.5 million from UFCW & Employers Benefit Trust v. Sutter Health settlement for the underwriting rate-setting process beginning with the plan year 2024. Commissioner Breslin seconded the motion.

#### 11. BOARD EDUCATION: ADDICTION SERVICES INCLUDING MEDICATION ASSISTED TREATMENT: (Discussion)

Eric Haram, LADC, Principal, Haram Consulting, LLC presented the following items:

President Scott noted Eric Haram's recommendation that people are assessed within 24 hours after first contact, which is beyond the state requirement of 10 days. President Scott wasn't sure that could happen in the current staffing environment of our health plans, although they are diligently trying to negotiate with existing staff, recruiting, and training new staff. Eric Haram said there isn't a simple solution though the legislation is strong and points towards investment in individuals accessing these services more rapidly. Eric Haram reiterated that the performance and outcomes for individuals with substance use disorders greatly improve with the rate of access getting better and fewer people falling through the gaps the shorter the wait time and the start of services.

Commissioner Follansbee asked if there is data on the future of virtual access to care. Eric Haram said the emerging data shows that the outcomes have at least been the same as before we used the technology and we've learned over the past two and a half years that the tools were woefully underutilized. The data is compelling enough that the Federal Drug Enforcement Administration (DEA) waivers granted during COVID-19 are going to be sustained a the end of the Public Health Declaration so providers will still be able to see their patients virtually for their healthcare, prescribe controlled medications and won't have to necessarily establish a face-to-face encounter before doing so. Eric said the regulating bodies don't' change easily and knowing access will continue is an indicator of the utility of the virtual treatment.

#### 12. SFHSS STRATEGIC PLAN 2023-2025: (Action)

Executive Director Yant commended Leticia Harris for leading the planning process and the management team's effort to work directly with their staff to develop the goals and objectives.

Commissioner Breslin asked how will advancing primary care, goal 2, be achieved. Iftikhar Hussain, Chief Financial Officer, SFHSS, said there are structured payment models for improving

primary care developed by organizations like Purchaser Business Group on Health (PBGH). The models are recognized by other payer organizations such as Covered California and CalPERS. Iftikhar Hussain said that because this is an aggressive goal, the Health Service System seeks to align with peers like Covered California and CalPERS to influence change among health plans and providers, e.g., improving access to primary care and integrating behavioral health into primary care. Commissioner Breslin said the problem is access and there aren't enough primary care providers. If tikhar Hussain agreed and said improvement could look like a leveraged model where infrastructure, systems, and teams support the physician. If the Hussain said the focus on primary care has evolved in the broader field and that its importance in the continuum of care has strengthened. If the Hussain expressed his optimism in taking this goal on and achieving alignment with other groups. Commissioner Breslin said medical students are offered monetary incentives to pursue primary care, but their training takes years, so the shortage continues. Executive Director Yant said provider shortage is an industry-wide dilemma and being a specialist is more lucrative than being a primary care physician. Executive Director Yant said alignment with purchaser groups like PBGH and Integrated Healthcare Association (IHA) can work collectively to shift payment structure to pay more for primary care providers. Executive Director Yant noted the emergence of Brown and Toland as an example. Executive Director Yant also noted that efforts to embed behavioralists can help to avoid physician burnout within primary care practices. President Scott said if this is an issue for our members then the Health Service System needs to be intentional and exercise its influence through alignment. President Scott said the goal is a well-articulated longitudinal goal that will focus attention on trying to get members gualitative services and over the next three-year cycle we'll see what marginal or substantial solutions are available for members. Commissioner Follansbee suggested metrics on primary care could be a good place to start, considering the percentage of our members who have primary care providers and what the access time is for primary care functions.

Commissioner Follansbee pointed out Strategic Goal 4-Mental Health and Well-Being's specific objective to enhance programs to support early retiree and retiree well-being. He clarified that this goal was drawn from robust conversations to replace deficiencies for the holistic health of those populations and that although this objective is specific to early retirees and retirees, there will be no less diligence in attending to mental health and well-being services for active members.

President Scott said the years need to be listed in chronological order on page 14.

President Scott read the Health Service Board endorsement for the strategic plan: The Health Service Board is dedicated to making high quality affordable comprehensive healthcare benefits available to SFHSS members and administering the trust in accordance with the charter. We are committed to our role as fiduciaries to assure that benefits paid for by the trust are available to all SFHSS members without special favor or privilege. The mission and vision of the Strategic Plan will inform and frame our efforts in the near future. This plan as a whole will serve as a policy reference, planning guide, and communication tool, as the Board interacts with all constituencies including but not limited to SFHSS leadership and administrative staff, and the offices of city government. In acknowledgment of that understanding, the Board at this meeting approves the design and development of the Strategic Plan. As the result, the Board will be active and diligent in the implementation, assessment, and evaluation of results of the Strategic Plan for the years 2023-2025 and beyond as we seek responsible stewardship to better serve our members.

Vice President Hao said the plan shows a deep commitment to areas that matter to members

and the ways they receive care and the sustainability of that care. Vice President Hao commended Leticia Harris and the management team on their work to produce the strategic plan.

Vice President Hao moved to approve and adopt the San Francisco Health Service Board Strategic Plan for 2023-2025. Commissioner Breslin seconded the motion.
