## **Education Survey Results for 2023**

Each year, the Commissioners and SFHSS leadership work in partnership to provide educational opportunities that enhance continuous learning. The Education Plan guides the SFHSS Leadership team to create a list of educational topics, offer educational resources, and Subject Matter Expert (SME) presentations to the Board throughout the year. Commissioners completed the annual Board Education survey to request topics for 2023.

- Topics are ranked in order from highest to lowest
  - 1st Healthcare Cost Trends (Active and Retirees)
  - 2<sup>nd</sup> Equity Data Reporting
  - 3<sup>rd</sup> Data Transparency

Commissioners suggested adding Modern Healthcare as a Board Education Resource. It was noted, newly appointed Board members will need fiduciary training as part of their onboarding. The full Board will receive Fiduciary training every three years, the next training will be in 2024.
